

**REACH SVHC certificate**

The Registration, Evaluation, Authorisation and restriction of Chemicals (REACH) Regulation EC No 1907/2006 is a regulation of the European Union, adopted to improve the protection of human health and the environment from the risks that can be posed by chemicals.

Under REACH, substances which are most hazardous to human health and to the environment are being gradually evaluated. Those found to meet the criteria in Article 57 of the REACH regulations are added to the 'Candidate List', and are then known as Substances of Very High Concern (SVHC). Further substances are added to the Candidate List every 6 months. The Candidate List was last updated in January 2021, and now lists 211 SVHCs.

Amphenol Ltd confirms that the part numbers listed in the table below contain more than 0.1% by weight of a REACH SVHC (except where specified otherwise).
