Dear Sir or Madam,

We follow the determinations of the REACH regulation and the resulting obligations. The following activities show our status of implementation:

We neither manufacture chemicals nor do we purchase chemicals in quantities more than 1 tons / year. Our products do not release any substances and are therefore not subject to the registration process. Based on the registration, however, we ensure that our suppliers (and their sub-suppliers) have registered their substances that are subject to registration.

We constantly ensure, that all safety data sheets which we use in our assembly production in Saarlouis, are updated and available at any time. The various applications of chemicals, that we use, are exempted from the general registration requirement.

With regard to the restriction process, we note that the products which we put on the market, may contain substances that are included in the "candidate list" according to SVHC (Substances of Very High Concern) and which, according to the REACH directive, have a concentration of more than 0,1% by weight. In order to meet our information obligation, we are in continuous contact with our supply chain to determine if the materials supplied to us contain one of the substances listed in the SVHC.

Amphenol Air-LB does not carry out by itself any independent analysis with regard to REACH. The statements on this declaration are based on technical data from our supply chain, which we assume to be reliable and correct. The information provided will be updated as soon as we become aware of any new features or supplements.

If Amphenol Air-LB GmbH discover materials on the SVHC list with a higher concentration than permitted by REACH, the concerned customers will be informed.
